## Minutes of the last AGM:

# Chair's report:

There followed a discussion about the rather urgent selection of a project for the LCCP funding. The originally planned hydroelectric scheme on the River Clywedog cannot go ahead because Severn Trent will not release the site in time, and so a possible alternative is a hydroelectric project on the Severn by the Short Bridge. Failing this the fallback plan is to install a photovoltaic generation system on the roof of the Community Centre. Somebody asked what had happened to the plan for a market stall in the Llanidloes Saturday market. It is hoped that a 10:10 campaign stall will be a regular, though not necessarily weekly, stall at the market.

There will be a 10:10 campaign after the meeting, and a showing of the film "The? Of Stuff".

### **Retirement and Election of Trustees**

Graham Brand, Paul Jarvis and Gwen Prince are standing down and not seeking reelection.

Nick Venti stood down by rotation, but was prepared to be re-elected. Colin Penfold and

Anne Levy also stood for election.
